

The February Group meeting was called to order by Chair Tim Cantwell at the City of Issaquah at 10:10 AM. Thanks to Todd Freeman for hosting the event.

James Salter reported that the balance in our account is \$16,312.04.

After introductions, there was immediately a motion to reimburse James for the purchase of a laptop for the Group's use. It can be used by any of the officers and will be kept with the secretary. There were many good reasons for the purchase, but foremost, to keep Group records with the Group other than on private or City computers. I have begun transferring records. The cost was \$601.16. The next order of business was to further discuss the new website design and contract. The motion was made and unanimously approved to accept the Nelson Design contract for the redesign. Just to recap, the website committee has held several discussions with Jeff Nelson and had many options available for viewing. Everyone agreed on which option we would like to go with, and it is going to be great! The agreement is that for \$599.00, Jeff will design the new website. The committee will meet after the regular meeting to evaluate and choose some of the content. Of course further discussions will be necessary to work out details. Once the website redesign is complete, we will be contacting vendors to see who is interested in advertising on the site. They will be charged a small fee, which will offset the cost of the project as well as assist us with the maintenance contract funding.

For the time being, Dennis will be the liaison between the Group members and Jeff for updates and information we would like to see in the future on our site, such as links and articles of interest. It was voted that in the future, the past chair will assume that responsibility for the next year.

### Other business:

Bob Eastwood will be attending the SRC4 meeting the week of the 24<sup>th</sup>. We previously voted to finance his trip and at this meeting we approved the purchase of a \$25.00 gift card to be used as a door prize. We are always thankful to Bob for representing The Group at these meetings. He brings back their ideas and fresh topics, as well as finding new guest speaker possibilities for our annual conference.

Finally, there was a brief discussion and a quick overview of the Annual Summary Report for the Department of Health. As most of you know

the ASR is due the first quarter of every year. This report summarizes the activities of the water purveyor for the previous year regarding their cross connection control programs. It requires much detail and often times raises questions as to interpretation of the guidelines. Instead of repeating all of the discussion, questions and opinionated answers, we advise you to make contact with Terri Notestine to receive accurate information if you have any questions.
