Coming Soon - New Newsletter for Waterworks Operators

The DOH Office of Drinking Water (ODW) will soon publish H_2Ops , a new newsletter designed for waterworks operators. We expect to publish the first issue of H_2Ops in September. Each issue will focus on a topic relevant to water system operations.

We plan to mail H_2Ops to operators and water systems four times a year. We will provide print copies of H_2Ops , because many operators prefer to receive hard copies of drinking water publications.

The *Water Tap* newsletter will return in January 2015 in an abbreviated format. We plan to publish Water Tap twice a year.

Office of Drinking Water Reorganization

Clark Halvorson, the new Director of ODW, has revealed his plans to reorganize our office. The reorganization will affect the CCC Program.

The good news is that under the reorganization, Clark's proposing to add more resources to the CCC Program. His plan creates a new CCC-related position in Operator Certification. We'll be looking for an experienced DOH-certified CCS to fill this position. The CCS will work closely with Terri. The CCS's potential duties may include responding to day-to-day CCC technical assistance requests, conducting CCC-related fieldwork, providing CCC training to operators, and conducting audits of ASR systems. The CCS will also provide technical assistance to Deni Gray on CCS and BAT complaint investigations.

In addition, a new employee, Dave Sternberg, will provide CCC Compliance and possibly other technical support to the CCC Program by taking on some of Simon

Tung's previous duties. Dave recently filled the Water Quality Compliance Programs Coordinator position in the Water Quality Section.

Under the reorganization, Terri's position is moving from the Water Quality Section to a newly created Engineering and Technical Services Section. Terri will still be the CCC Program Manager and the lead on CCC for the state. She will continue to be actively involved in CCC, but will be expanding her duties to include other distribution-related issues and possibly working on the state Needs Assessment.

Terri's main responsibilities right now include working with the:

- IT Section to get the ASR web-based application converted to a new more stable software platform for the 2014 ASR.
- CCC Workgroup. The Workgroup is continuing to evaluate the CCC Program and will be making recommendations to ODW Management on CCC data collection, compliance, and future program direction.

CCC-Related Complaints


