Most of the discussion was centered around planning for the October Seminar. It will be on October 18<sup>th</sup> at the Lynnwood Convention Center. Wednesday has reached out to numerous potential presenters, and we are waiting to hear back from them. Once confirmed, the agenda will be sent out to all.

### On a legal note:

Nonprofit organizations handling funds need the services of a banking institution just as any for-profit organization does. To open an organizational bank account, though, they also need authorized account signers. The organization's board members agree upon the signers in an official meeting, and the signers are expected to handle any of the organization's checking transactions that may arise. When it's time for a change in signers though, the bank must meet with the signers involved and have them complete paperwork for the switch to be binding. While each bank has its own specific changeover requirements, the rules for adding an authorized signer or switching a signer are generally the same across institutions.

We have voted to remove Mick Holte's name, since he has retired and Add Wednesday Smith. Dennis will still act as the number one signer as he is still the treasurer of the Group.

Thanks to Mick for volunteering his services for many years. He will remain active with the Group but enjoying the life of retirement at the same time. We are still looking for someone to volunteer for the treasurer position.

Our next meeting will be virtually on May 17<sup>th</sup>. Wednesday will give a presentation on Cross Connection Control Site Surveys. It will be really good! Join in.
