How to improve your Cross-Connection Control Program - Jessica Shaw, City of Wenatchee - PNWA AWWA ( 1hr )

#### **ABSTRACT**

Implementing a cross connection control program can be challenging and programs over time need to be evaluated for efficiency and effectiveness. The City of Wenatchee has been actively implementing a combination, premise isolation and inpremise protection, cross connection control program since 2002. This presentation covers surveying new and existing services, education and outreach, and backflow incident response. Cross connection control survey results and backflow incidents from the City of Wenatchee will be presented along with practical tips for conducting surveys, educating customers and training staff.
